

#### One Card Does It All! A Single Health & Welfare ID Card Will Meet All Your Health Care Needs

New Health Insurance ID cards will be mailed to your homes in December. These cards have been designed help simplify your access to health care coverage. All of our partners: Coventry, Delta Dental, Express Scripts, Mercy Managed Behavioral Health and VSP have all been included on one (1) new ID card.



Beginning January 1, 2015, you will simply need to present your new ID card when seeking health care benefits from any In-Network provider. Please destroy and discard your old cards after January 1<sup>st</sup> once you have received your new ID card in the mail.

#### **New Medical Explanation of Benefits (EOBs)**

Beginning in January, you will notice a difference to your medical EOBs. You will begin receiving your new EOBs in the mail for all claims processed for dates of service on or after January 1, 2015. All claims incurred December 31, 2014 and prior will continue to be available to you through Coventry. No need for confusion: Coventry is still our partner for medical coverage! The only change will be in the formatting of the EOBs that come to your home. Later in 2015, you will have the option to be able to view your EOBs in your own member portal online, but for now, everyone will be receiving paper EOBs to their addresses on file.




#### **Outlying Clinics & Biometric Screening Raffles**

# ANTIBIOTICS by, Mark Clark, Pharm.D., Pharmaceutical Strategies Group



With the winter and holiday season upon us there will be more of us gathering together in close places (malls, airports/planes, events) and sharing germs and, unfortunately, colds, flu and other infections with one another. As a result, visits to healthcare providers increase and, as the healthcare provider visits increase, so do patient requests for an antibiotics.

Antibiotics and similar drugs have been used for the last 70 years to treat patients who have infectious diseases. However, these drugs have been used so widely and for so long that the infectious organisms the antibiotics are designed to kill have adapted to them, making the drugs less effective. Proper use is critical. At least 23,000 people die each year as a direct result of infections that are resistant to antibiotics.

Antibiotic use is not without risk. Antibiotics can also kill good bacteria in your body which may lead to complications such as diarrhea or yeast infections, can cause serious allergic reactions as well as result in your getting an antibiotic-resistant infection later that resists antibiotic treatment.

#### WHEN ARE THEY NEEDED?

Antibiotics can only cure bacterial infections. Antibiotics are not for viral infections such as:

- > colds or flu
- > most coughs and bronchitis
- > sore throats not caused by strep
- > runny noses

Taking antibiotics for viral infections, such as a cold, cough, the flu, or most cases of bronchitis, will not:

- > cure the infections

#### WHAT CAN YOU DO?

If you have a viral infection, over-the-counter pain relievers, decongestants and saline nasal sprays may help relieve some symptoms. Of course, always use over-the-counter products as directed. Many over-the-counter products are not recommended for children younger than certain ages; however, your child's pediatrician may have suggestions for over-the-counter medications that are safe for your child.

Do not request or pressure your healthcare provider for an antibiotic if one is not prescribed. However, when prescribed an antibiotic:


- ➤ Take it exactly as the doctor tells you.
- Complete the prescribed course even if you are feeling better. If treatment stops too soon, some bacteria may survive and re-infect you.
- Throw away any leftover medication once you have completed your prescription

Remember, hand washing and keeping your hands away from your face are a couple of the most effective ways to reduce your risk from getting a cold or the flu.

# The Angry Child From your Member Assistance Program



Parenting can be quite challenging. As parents, we are expected to build self esteem, handle misbehaviors, help kids problem solve and encourage their personal development all in a day's

child. Strengthening
relationships with
our children is
what we strive for as
parents. Below are a few
tips for those "in the heat
of the moment" times,
as you deal with your
youngster.

- 1. Give your child some space when there is a "meltdown." Negative attention by parents can make the situation worse.
- 2. Take time out, break up the interaction and meet up later when your child has had time to cool down. Attempting to reason when either parent or child is angry will likely lead to frustration. Remember: *You are the one in control*.
- **3.** Accept that your child will be angry with you sometimes. Don't take it personally.
- **4. Hold your tongue and think before you speak!** When emotions are high, avoid saying things you might regret. There is never a just cause for being demeaning or hurtful.
- 5. When it feels like your child is pushing you away, stay close. This may be the time when they need you the most. Find some way to validate them.



# rotecting Your Pension: St. Louis

#### 1099Rs for Retirees of the Carpenters' Pension Trust Fund of St. Louis



Did you receive pension benefits from the Carpenters' Pension Trust Fund of St. Louis in 2014? If so, please note that Form 1099-R will be mailed by January 31, 2015. This is the form you will need to use when filing your 2014 tax returns.

If you received a monthly Carpenters' Pension benefit and you turned 59-1/2 during the 2014 Tax Year (between 1/1/2014 and 12/31/2014), you will receive two (2) separate 1099-Rs.

One Form 1099-R will be for pension benefits received prior to age 59-1/2 and will be coded as "2" for Early Distribution in box number 7. The second Form 1099-R will be for your pension benefits received after age 59-1/2 and will be coded as "7" for Normal Distribution. When the amounts of both 1099-Rs are added together, it will equal the total amount of pension benefits you received during the 2014 Tax Year.



# rotecting Your Health & Welfare Soaring Prescription Drug Costs Drawing Attention

Questions pertaining to the increase in prescription drug costs have

been steadily increasing in the Carpenters' Member Service Department over the past few months. Members are frustrated. Out-of-pocket costs have gone up. Carpenters' has not changed the prescription drug coverage, so why have some prescription drug costs gone up so dramatically? Why are families paying more money out-of-pocket for their prescription drugs?

It's not just our members. Plan costs have increased also. According an article by Matthew Perrone in

the St. Louis Post Dispatch on November 21, 2014, "some low-cost generic drugs...are seeing unexpected price spikes of as much as 8,000 percent." For example, one generic drug, antibiotic doxycycline hyclate, "rose more than 8,280 percent during a six-month period, to \$1,849 per bottle from \$20 per bottle." Now, that's something to talk about.

According to the article, it appears lawmakers are attempting to

introduce bills that will control prices. 


