What is the overall <u>deductible</u> ?	For <u>in-network providers</u> : \$300/individual or \$900/family For <u>out-of-network providers</u> : \$2,000/individual or \$6,000/family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> or until the total amount of <u>deductible</u> expenses paid by all family members meets theoverall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. In-network <u>preventive care</u> & immunizations, office visits, emergency room visits, in-network <u>urgent care</u> facility visits.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. # Does this plan provide Minimum Essential Coverage? Yes
