# Summary Annual Report for



## St. Louis-Kansas City Carpenters Regional Annuity Fund

This is a summary of the annual report for the St. Louis-Kansas City Carpenters Regional Annuity Fund, (Employer Identification No. 37-1942230, Plan No. 002) for the period May 1, 2022 to April 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$1,277,048. These expenses included \$607,068 in administrative expenses and \$669,980 in benefits paid to participants and beneficiaries. A total of 23,861 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$66,008,752 as of April 30, 2023 compared to \$43,691,380 as of May 1, 2022. During the plan year the plan experienced an increase in its net assets of \$22,317,372. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$23,594,420, including employer contributions of \$22,400,252, others contributions of \$2,706, losses of \$62,322 from the sale of assets, earnings from investments of \$1,356,423 and other income of \$-102,639.
