This is a summary of the annual report for the St. Louis-Kansas City Carpenters Regional Health Plan, (Employer Identification No. 43-1622970, Plan No. 501) for the period May 1, 2022 to April 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Trustees of Carpenters Benefit Plans of has committed itself to pay the following types of claims incurred under the terms of the plan.

All MEDICAL, DENTAL, VISION, PRESCRIPTION, AND DISABILITY claims

INSURANCE INFORMATION

The plan has contracts with UNION LABOR LIFE INSURANCE COMPANY, and METROPOLITAN LIFE INSURANCE COMPANY to pay the following types of claims incurred under the terms of the plan.

All LIFE, ACCIDENTAL DEATH AND DISMEMBERMENT claims

The total premiums paid for the plan year beginning May 1, 2022 and ending April 30, 2023 were \$2,130,820.

The value of plan assets, after subtracting liabilities of the plan, was \$155,173,285 as of April 30, 2023 compare to \$130,454,162 as of May 1, 2022. During the plan year the plan experienced an increase in its assets of \$24,719,123. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$276,483,669. This income included employer contributions of \$242,268,422, employee contributions of \$33,089,563, realized gains of \$482,846 from the sale of assets and earnings from investments of \$578,076. Plan expenses were \$251,764,546. These expenses included \$10,921,223 in administrative expenses and \$240,843,323 in benefits paid to participants and beneficiaries.
