## Raffle Drawing Rules

Carpenters Health Fairs Participation Raffle drawings are sponsored by the St. Louis-Kansas City Carpenters Regional Health Plan (“Plan”), made possible through external partner donations, and is governed by these official rules (“Official Rules”). By participating in the Participation Raffle at either the Kansas City, St. Louis, or Cape Girardeau health fair, each campaign participant agrees to abide by these Official Rules, and understands that the results of the raffle drawing, as determined by the Plan, and its partners, is final in all respects. The drawing is subject to all DOL and ACA requirements.

### ELIGIBILITY

Carpenters Health Fair Participation Raffle is open to all Covered Individuals under the Plan, including Active and Medicare Advantage participants, who are eighteen (18) years of age or older at the date of the applicable health fair in which the Covered Individual participates. The Plan has the right to verify the eligibility of each entrant.

### CAMPAIGN PERIOD

Kansas City: Carpenters Health Fair Participation Raffle will take place on September 21, 2024, between 8 a.m. CT and 12 p.m. CT. (“KC Campaign Period”).

St. Louis: Carpenters Health Fair Participation Raffle will take place on September 28, 2024, between 8 a.m. CT and 12 p.m. CT. (“STL Campaign Period”).

Cape Girardeau: Carpenters Health Fair Participation Raffle will take place on October 12, 2024, between 10 a.m. CT and 12 p.m. CT. (“Cape Campaign Period”).

### RAFFLE & WINNER SELECTION

All eligible entries received during the Campaign Period will be gathered into three separate databases at the end of the Campaign Period. Winners will be randomly selected in three separate raffle drawings, one raffle drawing per event, then submission entries verified. Winners will be announced on or after October 21, 2024. If a potential prize winner cannot be reached by a Plan representative within three (3) attempts, using the contact information provided at the time of entry, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize. Upon the request of the Plan, the potential winner may be required to return an IRS W-9 form. If a potential winner fails to comply with these official rules, that potential winner may be disqualified.

### PRIZES

Prizes have been selected by Plan representatives. Terms and conditions may apply. Incidental expenses and all other costs and expenses which are not specifically listed as part of a prize in these Official Rules and which may be associated with the award, acceptance, receipt and use of all or any portion of the awarded prize are solely the responsibility of the respective prize winner. ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZE IS SOLELY THE RESPONSIBILITY OF THE WINNER.

  - a) Schedule a physical to establish care with a Carpenters Wellness Center medical physician
  - b) Cholesterol screenings, finger stick, non-fasted
  - c) Flu shot
  - d) Blood pressure screening
  - e) Hearing screening, provided by Beltone Hearing
3. St. Louis: Campaign participants must participate in at least one (1) of the health opportunities offered at the St. Louis Health Fair on September 28, 2024, and will receive one (1) entry per opportunity:
  - a) Schedule a physical to establish care with a Carpenters Wellness Center medical physician
  - b) Cholesterol screenings, finger stick, non-fasted
  - c) Flu shot
  - d) Blood pressure screening
  - e) Hearing screening, provided by Concierge Hearing
4. Cape Girardeau: Campaign participants must participate in at least one (1) of the health opportunities offered at the Cape Girardeau Mini-Health Fair on October 12, 2024, and will receive one (1) entry per opportunity:
  - a) Schedule a physical to establish care with a Carpenters Wellness Center medical physician
