Vacation Redemption 2025

NEW PROCESS

New in 2025, participants who have earned a Vacation benefit in the 2025 Plan Year (hours worked May 1, 2024 - April 30, 2025) will <u>not</u> need to authorize their benefits to receive their Vacation payment. However, there are a few steps necessary before a participant's Vacation money may be deposited into the participant's account in June.

VERIFY your ADDRESS

Vacation Redemption will be accessible through a link in your Member Portal in 2025.

Visit **laborfunds.org/member-portal**, or scan the QR code above. If you have not yet set up your Member Portal account, follow the prompts to set up your account. Then, log in.

Once logged in to your secure Member Portal, verify your address by selecting the "house" icon for **Demographics**.



Then, find your name, and review your address and phone number. If your information is correct, great! However, if your demographics are NOT correct, select the "pencil" to edit your address and/or phone.



From your Member Portal dashboard, select the "truck" to review your reported **Work History**. Select VC from the drop down menu to review your Vacation deductions.

If you see a discrepancy, contact your employer or our office for assistance.

for Active participants with hours-based coverage

Continuing Hours-Based Eligibility

Look-Back Rule requires less hours beginning May 1, 2025

Effective May 1, 2025, a member who works at least **1400** credit hours during the four (4) previous Contribution Quarters (12 months), will have eligibility extended through the Benefit Quarter that next follows that Contribution Quarter.

Hours worked February - April 2025 will use the old Look-Back Rule, which requires 1440 hours during a 12 consecutive month period ending April 2025, for July - September 2025 coverage. The new rule requiring 1400 hours in the previous 12 months will apply for hours worked May - July 2025 for coverage October - December 2025.

As a reminder, hours-based eligibility under the health plan continues based on hours worked in **CONTRIBUTION QUARTERS** that extends eligibility into **BENEFIT QUARTERS** as shown on the following chart:

CONTRIBUTION QUARTER hours worked	provides coverage for	BENEFIT QUARTER eligibility period
May, June, July	\rightarrow	October, November, December
August, September, October	\rightarrow	January, February, March
November, December, January	\rightarrow	April, May, June
February, March, April	\rightarrow	July, August, September

There are four (4) **ELIGIBILITY TESTS** to determine continuation of coverage. They include:

- the **QUARTERLY RULE**,
- the LOOK-BACK RULE,
- the PLAN YEAR RULE, and
- the rule for EXTENSION OF HOURS-BASED ELIGIBILITY BASED ON ELIGIBILITY FOR DISABILITY.

Carpenters Dental Plan Update

for Active participants, pre-Medicare retirees, & Medicare Advantage participants who have elected dental coverage

Carpenters Dental Center coverage

Effective May 1, 2025, Carpenters Dental Center, located inside Carpenters Wellness Center-St. Louis, operated by Onsite Dental, will be part of the Delta Dental PPO Provider Network.

What this means for Carpenters Dental Center patients

Dental coverage at Carpenters Dental Center will be the same as dental coverage at any in-network Delta Dental PPO provider's office. Services and supplies provided by Carpenters Dental Center will be billed to Delta Dental using the Delta Dental PPO fee schedule, subject to copays and coinsurance as outlined in the Premium and Basic Dental Plan Schedules of Benefits, whichever applies to the patient's coverage. Carpenters' Dental Plan's Schedules of Benefits may be found on our website:



As a reminder, Premium Plan participants and dependents are free to obtain covered services and supplies from providers in Delta Dental's PPO or Premier Networks or from any non-network provider; however, the plan allows for higher benefits (you pay less out of pocket) in the PPO Network. Basic Plan participants and dependents have PPO and Premium coverage only.



When an Active participant is short of the required hours to continue eligibility,

there is an administrative process that takes place to determine how the participant and his family, if applicable, may choose to continue coverage under the health plan. Follow the process for a **COVERED INDIVIDUAL** losing hours-based coverage in the flow chart below.

"RUB SOME DIRT ON IT"

Overcoming Stigma in Men's Mental Health

"Rub some dirt on it," "walk it off," "only girls cry," and "be a man" are all common expressions that men hear when growing up. And today, while different words may be used, the message is still the same. The most pervasive and devastating stance in our current society is indifference, especially where men's behavioral health is concerned. Whether it is the suicide rate, lack of proper healthcare, or simply the refusal to seek behavioral health services, there is a crisis for men in today's world.

Today, men are battling more than just behavioral health concerns. They must also battle the myths that still exist, often preventing them from accessing services for their concerns. This stigma is one of the most impactful factors accounting for the suicide rate of men being nearly four times that of women.

The National Alliance of Mental Illness cites **five incorrect beliefs** that create barriers for men in seeking behavioral health services:

- Behavioral health concerns equal weakness.
- Men should be able to control their feelings.
- Real men do not ask for help.
- Talking about problems will not help.
- Men's behavioral health concerns create a burden for others.

The key to removing the stigma is to promote behavioral health services and support those who are seeking help with positive, supportive, and affirming statements. Visit **laborfunds.org** for tips for men taking care of their mental health.
