NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN EITHER THE SWEEPSTAKES.

The Carpenters Health Fairs Sweepstakes (the "Sweepstakes") are organized and conducted by the Mid-America Carpenters Regional Council Health Fund – St. Louis-Kansas City Region ("Plan"), made possible through external partner donations, and is governed by these official rules ("Official Rules"). By participating in the Sweepstakes at either the Kansas City, St. Louis, or Cape Girardeau health fair, each campaign participant agrees to abide by these Official Rules, and understands that the results of the Sweepstakes drawing, as determined by the Plan, and its partners, is final in all respects.

#### **ELIGIBILITY**

Carpenters Health Fair Participation Sweepstakes is open to all Covered Individuals under the Plan, including Active and Medicare Advantage participants, who are eighteen (18) years of age or older at the date of the applicable health fair in which the Covered Individual participates. The Plan has the right to verify the eligibility of each entrant.

#### **CAMPAIGN PERIOD**

Participants may enter into the Sweepstakes at any of the following health fairs during the particular campaign period specified below (collectively, the "Campaign Period").

- Kansas City: Carpenters Health Fair Participation Sweepstakes will take place on September 20, 2025, between 9 a.m. CT and 12 p.m. CT. ("KC Campaign Period").
- St. Louis: Carpenters Health Fair Participation Sweepstakes will take place on September 27, 2025, between 8 a.m. CT and 12 p.m. CT. ("STL Campaign Period").
- Cape Girardeau: Carpenters Health Fair Participation Sweepstakes will take place on October 11, 2025, between 10 a.m. CT and 12 p.m. CT. ("Cape Campaign Period").

### **HOW TO ENTER**

NO PURCHASE IS NECESSARY.

To enter, you must complete at least one activity at one of the health fairs listed above and complete an entry form located at that health fair. All entry forms must be completed and turned in at the health fair during that health fair's Campaign Period. Mailed, emailed or any other entry method will not be accepted. Each entry will require the entrant to provide their name, email address, and telephone number.

You may submit one entry per activity completed at the health fair. You agree to provide complete and accurate information on each entry form. Illegible, incomplete or inaccurate entries will be disqualified.

#### WINNER SELECTION AND PRIZE NOTIFICATION

All eligible entries received during each of the Campaign Periods will be gathered into three separate databases at the end of the Campaign Period corresponding to each health fair location. Winners will be randomly selected from entries received for each applicable health fair in three separate Sweepstakes drawings (one Sweepstakes drawing per event). Each drawing will be conducted by a representative of the Plan and the results of the drawing will be final. Selected winners that have been verified as eligible to win will be announced on or after October 21, 2025. If a potential prize winner cannot be reached by a Plan representative within three (3) attempts, using the contact information provided on the entry form, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize. The Plan reserves the right to select an alternative winner or not award a prize at all if forfeited. Upon the request of the Plan, the potential winner may be required to return an IRS W-9 form. If a potential winner fails to comply with these official rules, that potential winner may be disqualified. The Plan's decisions are based on its sole discretion and interpretation of these official rules, and are final and binding in all respects.

## **PRIZES**
