SUMMARY OF MATERIAL MODIFICATIONS

DEPENDENT ENROLLMENT CHANGE

Effective September 1, 2025

Participants are allowed 90 days from a qualifying event, such as a marriage, adoption, or a dependent child's birth, to enroll a new dependent under the MACRC Health Fund.

Previously, the Fund required participants to enroll dependents due to a qualifying event within 30 days.

The *Enrollment Form* and *Enrollment Form Required Documents* may be found on **laborfunds.org** under Health and Welfare Plan Resources. These forms are also available in your Member Portal.

If the *Enrollment Form* and all required documents are received within 90 days, coverage begins retroactive to the requested date. Otherwise, coverage will begin on the date that all documents are received.

MEMBER PORTAL

COBRA Payments

Effective September 20, 2025, you will be able to make your COBRA election by logging into your Member Portal account. If you are eligible for COBRA, your options will be available under the *COBRA* menu option.

Pension Estimates

If you've earned a vested benefit with the Carpenters Pension Trust Fund of St. Louis, you may now log into the Member Portal to estimate your future pension.

- **→** Log in on laborfunds.org/member-portal
- → Select *Pension Projections* from the menu
- → Then select *Pension Projections* at the top of the page
- ✦ Select OSP or SMP depending on your Pension Type
- ★ Enter your desired retirement date, type, and option
- ★ Repeat the last step with various dates, types and options to see how your benefit projection updates

UNDERSTANDING YOUR BENEFITS

Hearing Aids: The plan allows <u>up to</u> \$2,000 per ear after any applicable discounts, deductible, and coinsurance (once every five years).

Orthodontia: The plan pays 50% of the contracted amount with a maximum of <u>up to</u> \$4,000 (lifetime).

AD&D BENEFITS

for Actively Working Participants

The Plan provides Life Insurance and Accidental Death & Dismemberment (AD&D) benefits through MetLife for participants actively working and covered under the Active Plan. AD&D benefits cover losses resulting from accidents, such as death and injuries, such as loss of limbs or certain senses.

The **maximum AD&D Benefit** is **\$50,000**; however, the benefit may be paid to participants at scale:

Covered Loss	Benefit	Covered Loss	Benefit
Life	100%	Foot (below the knee)	50%
Hand (below the elbow)	50%	Leg (above the knee)	75%
Arm (above the elbow)	75%	Paralysis (both arms & legs)	100%
Thumb & Index finger (of the same hand)	25%	Paralysis (both legs)	75%
		Paralysis (arm & leg on either side of body)	50%
Any combination (hand, foot, sight one eye)	100%	Paralysis (one arm or leg)	25%
Sight (in one eye)	50%	Speech & Hearing	100%
Brain Damage	100%	Speech or Hearing	50%
Coma (on the 7th day)	1% monthly up to max 60 months	Third degree burn	% of the full amount equal to the % of body surface suffer- ing third degree burns



AD&D benefits do not cover losses to due to natural causes or injuries sustained while under the influence of drugs or alcohol.

WOMEN'S HEALTH & CANCER RIGHTS ACT

If a participant or dependent had, or is going to have, a mastectomy, they may be entitled to certain benefits under the Women's Health and Cancer Rights Act (WHCRA). For individuals receiving mastectomy-related benefits, coverage will be provided in a manner determined in consultation with the attending physician and the patient for:

- » All stages of reconstruction of the breast on which the mastectomy has been performed, or aesthetic flat closure surgery;
- » Surgery and reconstruction of the other breast to produce a symmetrical appearance; and
- » Prostheses and treatment of physical complications at all stages of the mastectomy, including lymphedemas.

These benefits are subject to the same eligibility, deductible and coinsurance rules applicable to other medical and surgical benefits provided under the Plan.

YOUR ANNUITY BENEFICIARY

Do you know who your beneficiaries are?

Under the Annuity Plan, your beneficiary is your spouse if you are married.

If you do not have a Beneficiary Form on file, are not married, and die before your accrued annuity benefit are paid, your beneficiary is defined by your Annuity Plan and will be paid in this order:

- 1. Equally to the participant's children, or, if no children, then
- 2. Equally to the participant's living parents, or if none, then
- 3. Equally to the biological siblings, or if no biological siblings, then
- 4. To the participant's estate.

To ensure your benefits go to the person you choose, download and complete an *Annuity Beneficiary Form* from our website. Then return it to us by mail or upload it to your Member Portal.

NAVIGATING THE WAIT

You did it!

You took a big step by scheduling your first counseling session. That takes courage—so congratulations! Now, you just have to wait for the day to come. Many people think the hardest part is over once the appointment is set. But is it really?

As musician Tom Petty once said, "the waiting is the hardest part." It's common to feel nervous as the day gets closer. Some people even think about leaving while sitting in the waiting room. That's totally normal. Trying something new can make anyone feel anxious. You already have things on your mind that led you to seek help, so it's important that the counseling process doesn't add more stress.

How can you feel more prepared?

Luckily, there are ways to make your first session feel easier. Psychology Today gives helpful tips about what to expect. First, know that feeling nervous is normal. You're about to talk about personal things with someone you don't know yet, and that can be scary. But your first session is usually just a chance to meet your counselor and learn how things will work.

BRING

- 1. Any questions you have.
- 2. Notes to share.
- 3. A notebook to take notes.
- 4. Just yourself.

WHAT TO EXPECT

It's OK to be nervous or feel anxiety. Know that your counselor is there to **help and support you**. What you discuss stays between you and your counselor.

GET READY

Think about your family history, your reasons for coming, and what you hope to get out of counseling. Talking openly helps your counselor understand you and create a plan that works for you. Remember, these sessions are for you—you get to guide the conversation.



Choose your way to save

Medications for maintenance or long-term use (90-day supply) should be filled through:

- » Express Scripts mail order or
- » a Restricted Retail Pharmacy.

If mail order or the Restricted Retail Pharmacy Network is <u>not</u> used, you will pay the full cost of the drug.
